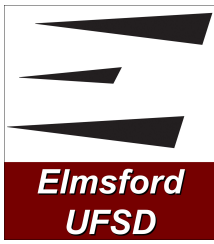

Equity for all students in any learning model

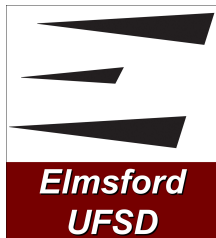
Provides an alternate between in-person and remote learning

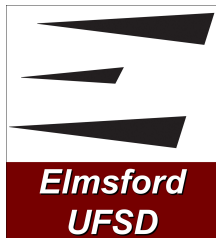


Blended Model Options

Cohort A= Last Name A-M Cohort B= Last Name N-Z

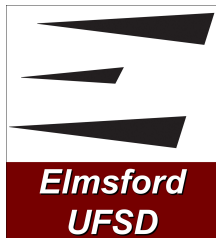

Wednesday (Virtual for ALL) Option

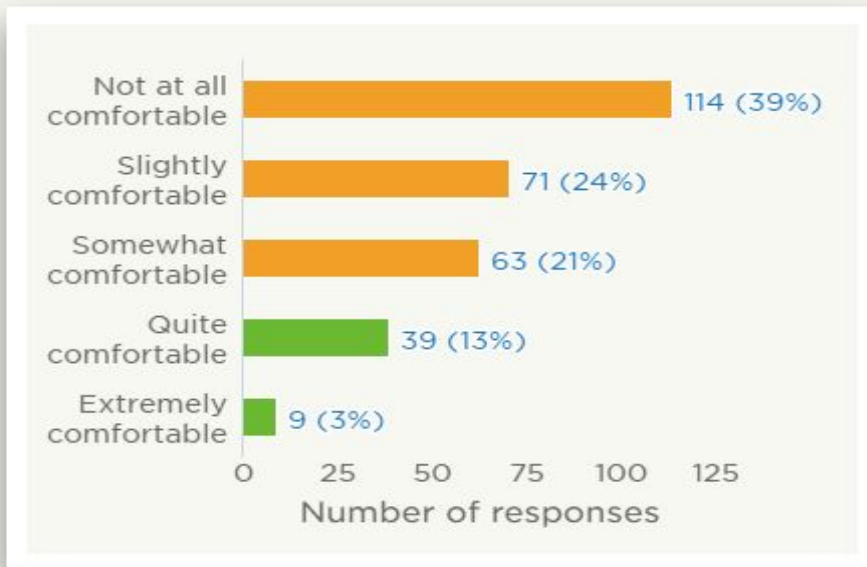
- All Students Learning from Home

 - Use to mitigate vacation day losses by cohort (Example below)

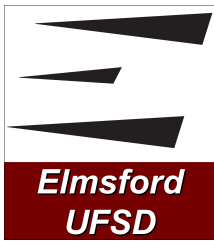

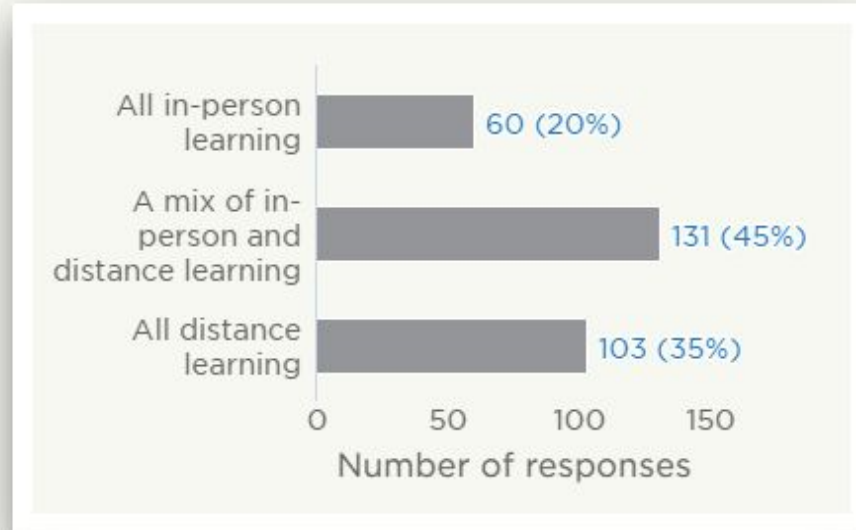
If in-person learning resumes in the fall, how comfortable are you having your child return to the school building?

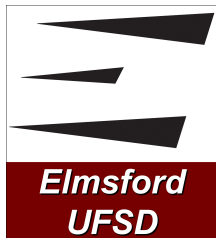

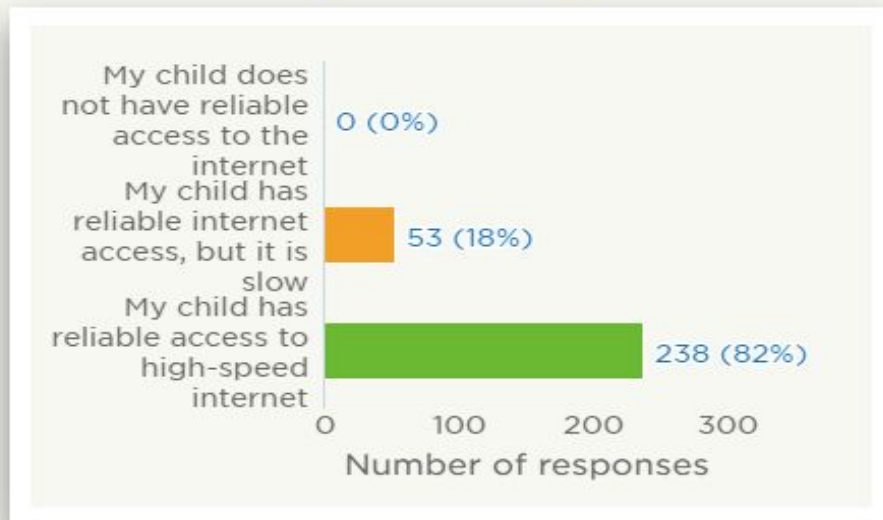
Assuming appropriate safety measures are in place, what is your preference for how your child returns to school in the fall?

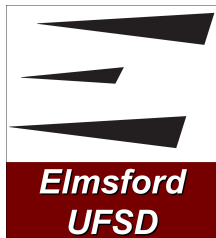




Community Survey Needs Assessment

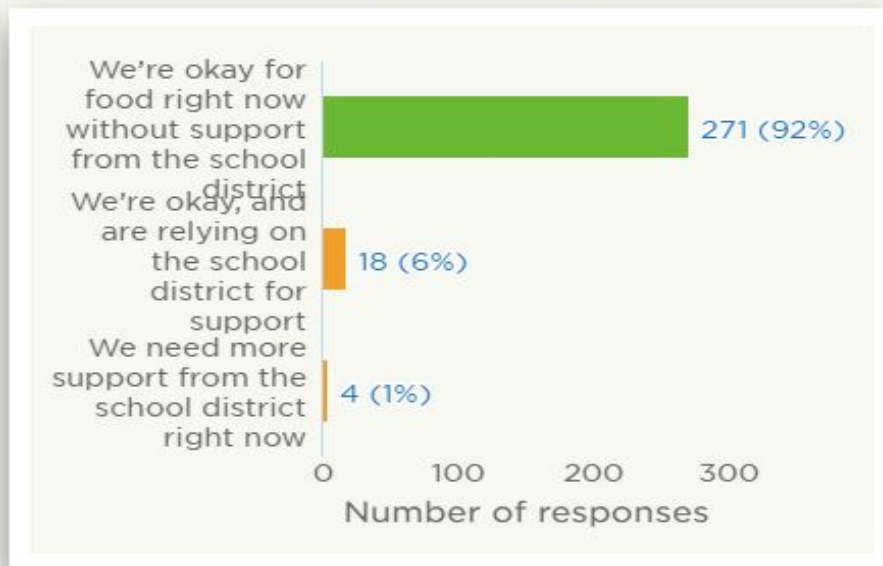
What best describes your child's typical internet access?

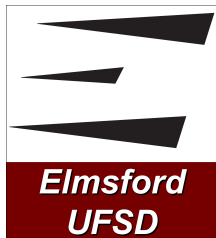




Community Survey Needs Assessment

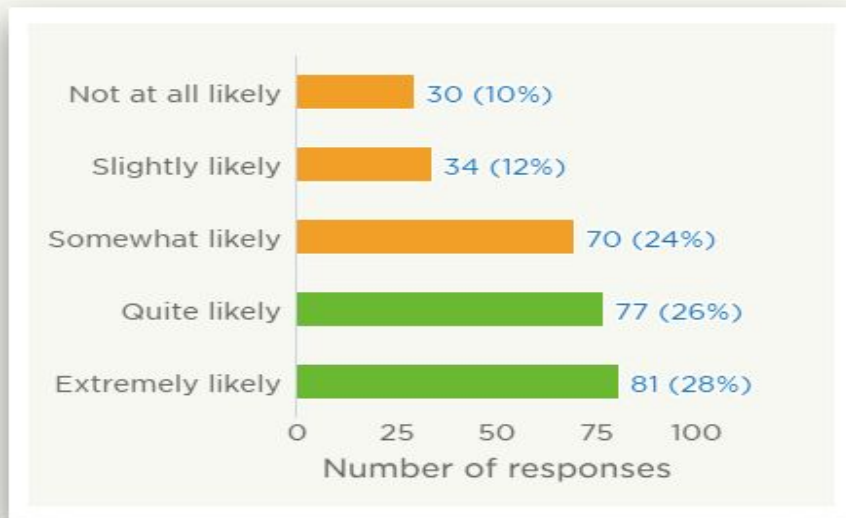
What best describes your family's food situation?



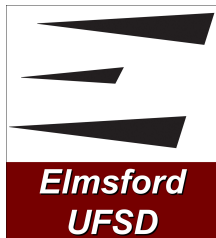


Community Survey Needs Assessment

How likely is it that someone will be able to provide learning support to your child if a form of distance learning continues in the fall?



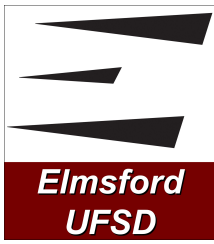

Daily Health Screenings

To help ensure the health and safety of all school community members the following will occur daily:

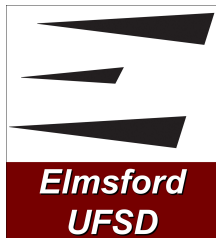
- All staff will complete and submit a daily health survey before coming to work
- Parents will complete and submit a daily health survey before their child comes to school
 - Survey questions will include the following:
 - Temperature
 - Symptoms Questionnaire
 - Travel Questionnaire
- School nurses will monitor student and staff health and implement procedures as necessary



Health and Safety Measures

The following procedures will be implemented within our schools:

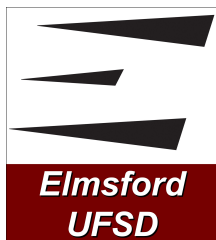
- All students, staff, and visitors will be required to wear masks
- Handwashing and respiratory hygiene practices will be incorporated into daily routines
 - Daily reminders and signage will posted throughout the schools
- Custodial and maintenance staff will perform routine cleaning protocols on high touch surfaces
 - Wednesdays will be utilized for additional deep cleaning
- Class changes will be minimized where possible to promote social distancing in hallways
- Lunches will be served in classrooms and/or additional eating areas are being designated, using outdoor spaces where possible
- Visitors will be limited and required to adhere screening procedures



Transportation

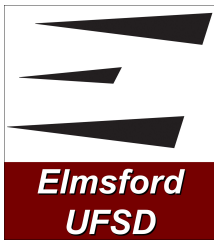
The district will work with White Plains Bus Co. to ensure safety for our riders.

- All students and transportation staff will be required to wear masks,
 - students who do not have a mask will be provided one
- Social distancing will be implemented, when possible
- Bus routes will be designed/restructured to minimize the number of students riding each bus (siblings may sit together)
- Transportation staff will perform daily cleaning protocols on high touch surfaces of the bus
